

# My Diaries

The first Parliamentary Diaries of Pakistan's National Assembly were published by MNA Marvi Memon in 2012 (My Diaries), in her first opposition tenure as Member of Parliament when she was part of PMLQ/PMLN. The book which is available at Saeed Book Bank, Islamabad is about 700 pages. It is the only diary of Pakistani parliament which gives a frank daily account of a parliamentarian with speeches, parliamentary documents, humanitarian struggle (inside parliament, on the streets, in judiciary). It is in short a personal account of parliamentary life as a single working mother. The period of political history covered from the inside benches of parliament is 2008- 2011.
